I. Spruch

Der Bescheid der Kommunikationsbehörde Austria (KommAustria) vom 19.08.2015, KOA 1.476/15-002, mit welchem die Standortänderung für die dem AGORA Verein „Arbeitsgemeinschaft offenes Radio – Avtonomno gibanje odprtega radia“ zugeordnete Übertragungskapazität „BAD RADKERSBURG 2 (Thermenarena) 92,6 MHz“ auf die Übertragungskapazität „GORNJA RADGONA (SVN) (Schloss Oberradkersburg – Grad Gornja Radgona) 92,6 MHz“ bewilligt wurde, wird gemäß § 62 Abs. 4 Allgemeines Verwaltungsverfahrensgesetz 1991 (AVG), BGBl. Nr. 51/1991 idF BGBl. I Nr. 161/2013, dahingehend berichtigt, dass dieser als Beilage 1 das diesem Bescheid beigelegte technische Anlageblatt der Übertragungskapazität „GORNJA RADGONA (SVN) (Schloss Oberradkersburg – Grad Gornja Radgona) 92,6 MHz“ enthält.

II. Begründung

Mit Bescheid der KommAustria vom 19.08.2015 wurde auf Antrag des AGORA Verein „Arbeitsgemeinschaft offenes Radio – Avtonomno gibanje odprtega radia“ (ZVR-Zahl 224485150 bei der BPD Klagenfurt, im Folgenden: Verein Agora) die dieser mit Bescheid der KommAustria vom 02.09.2014, KOA 1.476/14-001, gemäß § 3 Abs. 1 und 2 sowie § 5 iVm § 13 Abs. 1 Z 1 Privatradiogesetz (PrR-G), BGBl. I Nr. 20/2001 idF BGBl. I Nr. 86/2015, zugeordnete Übertragungskapazität „BAD RADKERSBURG 2 (Thermenarena) 92,60 MHz“ auf die Übertragungskapazität „GORNJA RADGONA (SVN) (Schloss Oberradkersburg – Grad Gornja Radgona) 92,6 MHz“ geändert.

Zur Begründung wurde u.a. ausgeführt, dass die beantragte Standortverlegung nach Durchführung eines internationalen Koordinierungsverfahrens technisch realisierbar sei und daher bewilligt werden könne. Dem gegenüber komme die Erteilung einer fernmelderechtlichen Bewilligung gemäß § 74 Abs. 1 Z 3 iVm § 81 Abs. 2 und 5 Telekommunikationsgesetz 2003 (TKG 2003), BGBl. I Nr. 70/2003 idF BGBl. I Nr. 44/2014, durch die KommAustria für den geänderten Standort nicht in Betracht, da sich dieser nicht auf österreichischem, sondern auf slowenischem Gebiet befinde.

Gemäß § 3 Abs. 2 PrR-G sind in der Zulassung u.a. das Versorgungsgebiet festzulegen und gegebenenfalls die Übertragungskapazitäten (§ 2 Z 4 PrR-G) zuzuordnen.

Gemäß § 62 Abs. 4 AVG kann die Behörde Schreib- oder Rechenfehler oder diesen gleichzuhaltende, offenbar auf einem Versehen beruhende Unrichtigkeiten in Bescheiden jederzeit von Amts wegen berichtigen.

Der Bescheid der KommAustria vom 19.08.2015, mit dem die Zulassung im Hinblick auf den Sendestandort geändert wurde, enthielt in der Beilage irrtümlich kein technisches Anlageblatt der neuen Übertragungskapazität, sondern lediglich eine leere „Seite 6“.

Hierbei handelt es sich um einen einem Schreibfehler gleichzuhaltenden, offenbar auf einem Versehen beruhenden Fehler, welchen die Behörde gemäß § 62 Abs. 4 AVG jederzeit von Amts wegen berichtigen kann. Das Anlageblatt wurde daher mit dem vorliegenden Berichtigungsbescheid ergänzt.

Es war daher spruchgemäß zu entscheiden.

III. Rechtsmittelbelehrung

Gegen diesen Bescheid steht der/den Partei/en dieses Verfahrens das Rechtsmittel der Beschwerde gemäß Art. 130 Abs. 1 Z 1 B-VG beim Bundesverwaltungsgericht offen. Die Beschwerde ist binnen vier Wochen nach Zustellung dieses Bescheides schriftlich, telegraphisch, fernschriftlich, im Wege automationsunterstützter Datenübertragung oder in jeder anderen technisch möglichen Weise bei der Kommunikationsbehörde Austria einzubringen. Die Beschwerde hat den Bescheid, gegen den sie sich richtet, ebenso wie die belangte Behörde, die den Bescheid erlassen hat, zu bezeichnen und die Gründe, auf die sich die Behauptung der Rechtswidrigkeit stützt, das Begehren sowie die Angaben zu enthalten, die erforderlich sind, um zu beurteilen, ob die Beschwerde rechtzeitig eingebracht wurde. Für die Beschwerde ist eine Gebühr in Höhe von EUR 30,- an das Finanzamt für Gebühren, Verkehrssteuern und Glückspiel (IBAN: AT830100000005504109, BIC: BUNDATWW, Verwendungszweck: „Bundesverwaltungsgericht / GZ KOA 1.476/15-003“, Vermerk: „Name des Beschwerdeführers“) zu entrichten. Die Entrichtung der Gebühr ist durch einen Zahlungsbeleg oder einen Ausdruck über die erfolgte Erteilung einer Zahlungsanweisung nachzuweisen.
