

## Process BEREC Work Programme

- BEREC Regulation (EC) No 1211/2009 sets out framework for annual BEREC WP
- WP 2017 to be adopted by BoR at the end of 2016
- Prior to that, public consultation of draft WP to ensure transparency and stakeholder participation
- After adoption by BoR, WP to be transmitted to EP, Council and Commission



Draft BEREC Work Programme 2017 follows the 3 pillars of the BEREC strategy 2015 - 2017


